LOCALS PEDAL THROUGH A NAKED BIKE RIDE IN SF

Shortly before noon on Saturday, March 9, a group of nude and semi-nude bike riders took a few minutes to ride around Justin Herman Plaza in the heart of San Francisco. The reason was to ride in solidarity with other naked bike rides being held across the Southern Hemisphere on the same day (the northern hemisphere celebrates World Naked Bike Ride in June). There also was some in-your-face attitude toward the Board of Supervisors after the recent ban on nudity in the city.

By the time the hour-long event was over, perhaps a total of 80 bikers participated adorned with bubble pack, latex body paint, very sheer garments, drapes, and anything else to avoid the totally nude definition of the new city ordinance, with another 100+ pedestrians armed with cameras looking on. News radio 810 repeatedly announced what was happening at the Plaza, and that helped attract even more onlookers, including a policeman who wanted to pin down who was the organizer of the event. Of course there was no one in charge (this is San Francisco, after all), so he soon left, perhaps a little frustrated.

After that some of the worn garments started to be removed. Some of the top-free women, being both lively and spirited, assisted others with their body painting and happily posed for pictures. Close to 1PM, the bicyclists made a few rounds of the Plaza and then left for Embarcadero before heading home. It really was a fun experience! They will do it again in June to celebrate WNBR with the Northern Hemisphere.

BARE TO BREAKERS MAY 19

The annual Bare to Breakers 5K Run through San Francisco is scheduled for Sunday, May 19, 2013.

This time, it is totally legal! (A little perk form the city's newly-enacted anti-nudity ordinance makes an exception for permitted events like Bay to Breakers.)

Registration is required for Bay to Breakers runners. See their web site http://baytobreakers.com/ to complete the on-line registration form. Advance registration is no longer needed to run nude, however, it is still a good idea to visit the BARE TO BREAKERS web site http://baretobreakers.com/ to read and understand everything on it before you race/walk/whatever.

OTHER NUDE NEWS SOME CALIFORNIA STATE PARKS SHOULD GO TO LOCAL AGENCIES, STUDY INDICATES

03/26/13 -- The Sacramento Bee reported that a study released by the Little Hoover Commission recommends California should consider giving up some of its state parks and turn them over to local agencies permanently. The 120-page report is the result of a year-long investigation that started before financial scandals emerged in July 2012 at the California Department of Parks and Recreation.

Among other things, department leaders were found to be hiding \$20 million even as they moved to close 70 of the 278 state parks because of state budget cuts. Numerous other government agencies have probed these events.

The 13-member Little Hoover Commission, appointed by the governor and Legislature, chose to focus on long-term survival of the state parks system, the largest in the nation.

The most controversial of six recommendations calls for appointing an advisory council to decide which parks have "statewide significance" and which serve more regional or local needs. Those in the latter category, the study says, should be transferred to local agencies.

The commission found that the parks department is burdened by an obsolete management structure; it can't raise enough money from visitor fees to replace cuts in state funding; and land acquisition over the last two decades has overwhelmed maintenance budgets.

Carolyn Schoff, president of the California League of Park Associations, said she was pleased by the study overall, but the idea of eliminating parks will be difficult for many supporters to accept. "Certainly we want to keep our park system intact," she said.

In a related recommendation, the commission urges the governor and Legislature to commit to a consistent level of general fund support for parks, and to allow parks to keep more of the money they generate locally. Park superintendents have been reluctant to try innovations that would boost revenue because they knew the money would not help their park but would end up in Sacramento.

The commission also recommends that state parks should add a new job classification of "**park manager**." This would allow employees other than park rangers, who must have peace officer training, to oversee a park.

Currently, only park rangers with peace officer training can rise to the position of park superintendent. This increases training costs for the department and may exclude park employees with special skills, such as historians and archeologists, from supervising parks.

The commission acknowledged that the parks department does **not have enough park rangers to ensure the safety of visitors** and staff, and to fulfill the park ranger's classic role of educating visitors about nature and history.

But instead of simply hiring more rangers, the study urges the state to launch an independent review of crime trends in the parks. This would reveal the most pressing law enforcement problems so rangers can be hired and deployed appropriately.

State parks spokesman Roy Stearns said the study accurately reflects many challenges the department has struggled with in recent years. He said the agency is open to looking at divesting some of the parks, and supports creating the new "park manager" job classification.

"This validates all that I've seen in the first four months that I've been here and want to work on," said state parks director Anthony Jackson, who was appointed by Gov. Jerry Brown in November.

Tim Mullin, AANR's Government Affairs Chair, said he agreed with the report's conclusion that the state park rangers need civilian oversight. "That is the united message we nudists/naturists have been telling them for years. We are willing to provide direction and assistance with our parks if they will let us."

WISCONSIN CLOSES MAZO NUDE BEACH ON WEEKDAYS, CITING "SEX AND DRUGS"

03/19/13 - Wisconsin authorities announced Tuesday they will shut down one of nation's most popular nude beaches on weekdays after struggling for years to "curtail sex and drugs on the sandbar" and surrounding woods.

In response, the state Department of Natural Resources announced it will close the beach and the surrounding woods to the public on weekdays, when wardens say troublemakers tend to operate unseen. The closures begin immediately. The area will remain open on weekends.

Nudists from around the country have been traveling to the public beach on the Wisconsin River near Mazomanie, about 25 miles northwest of Madison, for decades. The DNR estimates as many as 70,000 people, some from as far away as Florida, have visited the beach some summers But state officials allege visitors aren't just stripping down, they've also been slipping off into the woods for trysts and drugs.

Bob Morton, executive director of the Austin, Tex.-based Naturist Action Committee, criticized the DNR for not consulting with beachgoers before closing the area.

"Honestly, we're on their side when it comes to enforcing things that are lewd and lascivious," Morton said. "There's something to be said about consulting the users of the place. There's got to be more to this somewhere."

Nate Kroeplin, who supervises DNR law enforcement in Dane County, said wardens reviewed data on citations and determined most violations happen on weekdays, when fewer people are around to police each other's behavior. Of the 92 citations wardens issued for disorderly conduct or drugs in the beach area between 2008 and 2012, 83 were given on weekdays, he said.

[70,000 visitors each summer and only 92 citations over five years? We suspect something else is going on here. – Ed.]

HOW TO RSVP AND PAY FOR SCNA PARTIES AND ACTIVITIES

To encourage payment in advance, we have instituted a \$5 surcharge for people who reserve during the last 48 hours because in the past too many people RSVP without paying and then just don't show up after we buy the party supplies.

Payments by cash or check are accepted, but we prefer you pay by credit card through our on-line PayPal (you don't need a Pay Pal account yourself to use ours). We accept MasterCard, VISA, Discover, and American Express through our Pay Pal system.
